ORDINANCE NO. 1705 (2023)

**AN ORDINANCE TO AMEND THE REVISED GENERAL ORDINANCES
OF THE CITY OF SEA ISLE CITY, CHAPTER 21, SECTION 21-1.2
ENTITLED "FEES AND CHARGES" TO REFLECT A NEW PRICE
SCHEDULE FOR THE PURCHASE OF BEACH BADGES.**

WHEREAS, the City of Sea Isle City has in effect Chapter 21 Section 1-2 b., c., d., and e., pertaining to the fees necessary to improve, maintain, protect, and police the beaches in the City of Sea Isle City; and

WHEREAS, the Council of the City of Sea Isle City deems it both necessary and desirable for the City of Sea Isle City to amend the subsections of 21-1.2 that pertain to fees charged for beach access; and

WHEREAS, Council of the City of Sea Isle City finds that an increase in the fees for beach access in the City of Sea Isle City is in furtherance of the health, safety, and general welfare of the citizens and visitors of the City of Sea Isle City; and

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Sea Isle City, County of Cape May, and State of New Jersey as follows:

SECTION I. Subsection 21-1.2 b. of the Revised General Ordinance, entitled "Fees and Charges" is hereby amended to delete this subsection in its entirety and replace same as follows:

**DELETED SECTION:
21-1.2 Fees and Charges.**

- b. \$20 per person per season provided that application is made to the proper authorities on or before the cut-off date of May 15th of each year.

**REPLACEMENT SECTION:
21-1.2 Fees and Charges.**

- b. \$25 per person per season provided that application is made to the proper authorities on or before the cut-off date of May 15th of each year.

SECTION II. Subsection 21-1.2 c. of the Revised General Ordinance, entitled "Fees and Charges" is hereby amended to delete this subsection in its entirety and replace same as follows:

**DELETED SECTION:
21-1.2 Fees and Charges.**

- c. \$25 per person per season in the event that application is made to the proper authorities subsequent to the cut-off date of May 15th of each year and for the remainder of the bathing season.

**REPLACEMENT SECTION:
21-1.2 Fees and Charges.**

- c. \$30 per person per season in the event that application is made to the proper authorities subsequent to the cut-off date of May 15th of each year and for the remainder of the bathing season.

SECTION III. Subsection 21-1.2 d. of the Revised General Ordinance, entitled "Fees and Charges" is hereby amended to delete this subsection in its entirety and replace same as follows:

DELETED SECTION:

21-1.2 Fees and Charges.

- d. \$10 per person per week for any week or fractional part thereof of the bathing season. Weekly badges shall be valid from Saturday at 10:00 a.m. to the following Saturday (eight days later) at 5:00 p.m.

REPLACEMENT SECTION:

21-1.2 Fees and Charges.

- d. \$15 per person per week for any week or fractional part thereof of the bathing season. Weekly badges shall be valid from Saturday at 10:00 a.m. to the following Saturday (eight days later) at 5:00 p.m.

SECTION IV. Subsection 21-1.2 d. of the Revised General Ordinance, entitled “Fees and Charges” is hereby amended to delete this subsection in its entirety and replace same as follows:

DELETED SECTION:

21-1.2 Fees and Charges.

- e. \$5 per person per day for a daily bathing privilege subsequent to the City observed day for Memorial Day.

REPLACEMENT SECTION:

21-1.2 Fees and Charges.

- e. \$10 per person per day for a daily bathing privilege subsequent to the City observed day for Memorial Day.

SECTION V. Severability. If for any reason any section of this Ordinance shall be declared illegal by any Court of competent jurisdiction, the remaining section of the Ordinance shall remain in full force and effect, notwithstanding.

SECTION VI. Repealer. Any Ordinance or provision thereof inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.

SECTION VII. Publication. This Ordinance shall take effect immediately upon the adoption and publication in accordance with the law.
