Applicant proposes to reconfigure existing lot lines delineating five (5) existing parcels in the City's R-2 Zoning District. The properties, collectively, are the site of 3 existing units. The proposed subdivision will permit construction of three (3) duplex structures and one (1) single-family structure, for a total of seven (7) new units.

Applicant requests the following waivers:

- 1. 32-3.2(d) Contours
- 2. 32-3.2(e) Topographical Data
- 3. 32-5.2 Sanitary Sewer
- 4. 32-5.3 Storm Drainage
- 5. 32-5.4 Water System
- 6. 32-5.5 Fire Hydrant
- 7. 32-5.6 Underground Wiring
- 8. 32-6.22 Traffic Impact Study

Each lot shall submit a stormwater management plan at the time of construction permitting in accordance with 26-38.2 Standards Applicable to Minor Development.

The proposed subdivision proposes adjustment of existing lots lines delineating separately owned lots and does not result in any affordable housing obligation for several reasons. First, §26-43.2.2(a) excludes development permitted by the City's zoning ordinance as of November 14, 2017 from any affordable housing requirements. In the present case, the subject property is comprised of 5 separate lots, permitting each to be developed with a single-family unit as of November 14, 2017. Second, the property was developed with at least 3 separate residential units in 2017 and currently remains developed with 2 existing units, such that in no event will the project result in a net increase of 5 units necessary to trigger the affordable housing obligations under §26-43.2.2(b). Third, the project does not involve "multifamily development", since a multiple family dwelling is defined as a building under a single roof with 3 or more dwelling units. No such building is proposed in this case.
