## **RESOLUTION NO. 2017-08-01**

WHEREAS, the Planning Board of Sea Isle City, Cape May County, New Jersey ("Board") has reviewed the City of Sea Isle City Master Plan Re-Examination Report (the "Master Plan") attached hereto as Exhibit A; and

WHEREAS, the Board after an August 2016 regular meeting and a September, 2016 Public Hearing held in regards to the Master Plan Re-Examination Draft Report followed by an October 2016 regular meeting wherein public comment and changes from the August 2016 meeting were taken under advisement and incorporated into a revised November 2, 2016, Master Plan Re-Examination Draft Report, which was presented to the Board and reviewed at the November 2016 meeting; and

WHEREAS, at the November 2016 meeting, the revised Master Plan Re-examination Draft Report for the City of Sea Isle City was discussed but delayed adopting due to the City's Fair Share Housing Plan, which had not been completed, therefore the Board decided to wait until the Fair Share Plan was completed before adopting the Master Plan Re-Examination Report; and

WHEREAS, the Fair Share Housing Plan is taking longer than anticipated, therefore the Board is recommending the Master Plan Re-Examination Report be adopted without addressing the Fair Share Housing Plan; and

WHEREAS, at the August 14, 2017 meeting, additional changes to the Master Plan Re-Examination Report were discussed and final adoption of the Master Plan Re-Examination Report was brought up for vote and subsequently adopted; and

WHEREAS, the Board finds that the notice provision of N.J.S.A. 40:55D-13 have been

satisfied; and

WHEREAS, the Board has determined that the proposed revisions to the Master Plan

Re-Examination Report satisfies the requirements of the Municipal Land Use Law, N.J.S.A.

40:55D-1, et seq.

NOW, THEREFORE, BE IT RESOLVED by the Planning Board of the City of Sea

Isle City, New Jersey on this 11<sup>th</sup> day of September, 2017, that the City of Sea Isle City Master

Plan Re-Examination Report is adopted.
