First Applicant – Sports Development, Inc. for property at 33rd Street & Landis Avenue, Block 33.03, Lots 23 & 24. Michael Fusco – Attorney on behalf of applicant – who helped them obtain original approvals 20 years ago is now requesting to have a Condition, specifically Condition No. 4, removed from the Resolution with regards to a prior agreement providing parking on adjacent lots 11 & 12, due to the agreement having long since expired and parking no longer being a requirement per changes to the Ordinance since then.
