### 1) Ordinance No. 1637 (2019) Master Plan Consistency Review

To Revise General Ordinances of City to Amend Chapter 10 entitled "Building and Housing" to amend Construction Code Schedule(s) to Conform with State Statutes

<u>Professionals:</u> Board Engineer notes that there are changes not only to Chapter 10 entitled Building & Housing but within Chapters 26 & 13 as well as he moves into a review of his consistency report provided to the board, where he points out how Construction & Fire Subcode Fees, as well as Zoning Permit fees are amended to be current with the State of New Jersey.

<u>Board Comment</u>: the question is asked as to which Master Plan this is not inconsistant with, so it is explained that the entire Master Plan Procedure is done by the Planning Board.
